Chancellor's Regulation A-660

- Chancellor's Regulation A-660 (CR A-660) ensures the formation of a Parent Association or Parent-Teacher Association in every New York City public school and a Presidents' Council in every community school district, borough for high schools, and District 75.
- CR A-660 was revised on June 26, 2012.
